The Banded earplug hearing protector must be properly worn to provide effective protection. Follow these instructions and contact supplier.

FITTING INSTRUCTIONS

- 1. Pods should be clean before use.
- 2. Put the neckband under the chin or over the head.
- 3. Hold the large ends of the pods and swivel them to direct the tips into the ear canal openings. Firmly push and wiggle the pods into the canals until a snug seal is obtained.

5. Use spare pods to replace damaged or worn pods.

6. How to replace: Just take the pods off and insert new pods to the ends of

headband.

CLEANING

The headband can be cleaned and disinfected in mild liquid detergent and warm water.

After washing, dry with a soft cloth without undue rubbing. Washing may be repeated

several times.

WARNING

1. If the above recommendations are not adhered to, the protection afforded by the

ear plug will be severely impaired.

2. Harmful noise levels may be induced if the headband is struck.

This product may be adversely affected by certain chemical substances. Further

information should be sought from the manufacturer.

Arco 2E0400UK plugs should be stored in a clean, dry area before and after use.

Headband needs to be stored in re-closable packaging bag supplied by manufacturer

before and after each use.
